Finding the right fit for your little ripper is easy thanks to height-adjustable suspension, handlebar position, subframe, and bodywork, taking the seat height from a low setting of 634mm to a taller setting of 682mm.

A proven Dell'Orto type PHBG 19 BS carburetor takes prime position in producing the goods in the 2025 KTM 50 SX FACTORY EDITION, with settings that work perfectly in harmony with the engine, exhaust, and air intake design. And specific to the KTM 50 SX FACTORY EDITION, the reed valve case features a "double stage" concept, with an additional set of membrane flaps for even better gas atomization.
